

 I. State Farm Claims & Adjusters PHOENIX AND PALM SPRINGS AREA

A. Claim #1: 2/2/2019 Claim #2: 2/22/2019

Reported 2/2/2019 approx 1 pm; within hour of event;

Claim #2 was suggested by ADJUSTER JOEY to address the incomplete demolition/mitigation & unmitigated water damaged discovered after build back & after multiple UNACCEPTABLE AIR QUALITY ENVIRONMENT REPORTS (WHICH COINCIDE WITH THEIR DIAGRAMS OF WATER DAMAGED WALLS THAT WERE NOT DEMOLISHED AND/OR REMEDIATED IN FEBRUARY.

ADJUSTER RANDY WAS KEPT APPRISED MULTIPLE TIMES A WEEK AS TO THE DESTRUCTION BEING WAGED BY THEIR PREFERRED VENDORS. HELP WAS REQUESTED TO REPLACE THEM AND REPORT FRAUD. HE REFUSED REPEATEDLY AND PROTECTED THE VENDORS MISCONDUCT THAT CAUSED EXTREME PERSONAL AND PROPERTY DAMAGE AND LOSSES

II. State Farm Preferred Vendors

- A. When asked about the claims process, they provided numbers of 3 water remediation; when those failed to respond, they dispatched Contractor Connection who dispatched PDR AT NO TIME WAS INSURED ADVISED SHE COULD 'CALL A ROOFER' or even WATER REMEDIATION COMPANY. She disclosed she is disabled and asked the process.
 - Paul Davis Restoration (Arrived 2/4/2019 - then called Elite Roofing, who arrived soon after; ServPro arrived shortly after PDR & PDR authorized them to stay

- STATE FARM sent letters dated end of February 2019, 'confirming" bogus named vendors- after all damage by vendors reported - regarding the preferred vendor program - PERMISSION WAS ASKED ON 3/7/2019 TO DISMISS AND REPLACE GENERAL CONTRACTOR; ADJUSTER APPROVED AND CONVEYED DISMISSAL
- 3. ServPro (Arrived 2/4/2019 after PDR)
- III. Contractor Connection
 - A. PAUL DAVIS RESTORATION 2/4/2019- 3/8/2019 APPROX
- IV. STATE FARM via Contractor Connection Dispatched Paul Davis Restoration as General Contractor 2/4/2019; upon arrival, PDR called local roofing contractor for estimate; advised Insured that \$7,000 cash would be required for a fast roof, outside of the policy. Insured did not have \$7,000 cash. PDR caused 40 day delay in roof replacement, causing catastrophic damage to home and health, with full knowledge of State Farm Phoenix Adjuster and Managers.

Roof estimate not provided to Insured till approximately March 8, 2019, via adjuster. PDR repeatedly referred to State Farm as the "client" and would provide no details to "insured" without authorization from State Farm. CATASTROPHIC DAMAGE RESULTED

(Covered up by State Farm adjuster in collusion with other vendors)

A. FAILED PACKOUT WITHOUT DRYING, CLEANING INTO FORMERLY USED BOXES; DISCUSSED, ORGANIZED, NEGOTIATED AND AUTHORIZED BY STATE FARM APPROX 10 DAYS AFTER ROOF BLEW OFF; OPTIONS NOT DISCUSSED W/INSURED - GARAGE WAS EMPTY. NO CONTRACT PRESENTED UNTIL DAYS AFTER, AT HOTEL, WHEREIN PDR REP SAID THEY 'FORGOT' TO GET WORKORDER SIGNED; AND THAT 3 DAY RIGHT TO CANCEL MUST BE WAIVED. INSURED GASPED AT THE \$8,000 CHARGE AND WAS TOLD, 'DON'T WORRY ABOUT IT. STATE FARM AUTHORIZED IT. JUST SIGN IT THAT YOUR THINGS WERE PACKED OUT. INVENTORY WILL FOLLOW'. Inventory did not follow, nothing was cleaned, everything was destroyed; State Farm paid approximate \$8K to insured for household goods loss — AN ENTIRE HOUSEHOLD

 Paul Davis Restoration proposed (signed)settlement agreement with full & complete waiver of liability, changing scope of work to approximately \$3,000 to be kept a secret from State Farm- it appeared to be insurance fraud to insured, so she declined and reported to State Farm Adjuster requesting legal intervention.

V. ServPro Palm Springs

- A. On 2/4/2019— ServPro arrived approximately 1 hour after PDR homeowner asked if the water remediation company should be sent away since PDR would handle whole project; representative said, 'no, don't send them away; we are busy, i can work with them'
- B. ServPro arrived at loss site on 2/4/2019, approved by PDR as GC, and visited regularly, systematically demolishing and destroying the house and increasing water damaged areas because the poorly installed temporary tarp failed, they refused to replace tarp after subsequent storms that homeowner requested and adjuster authorized, for weeks. PDR said they could not install a roof until demolition was done; ServPro said that was BS.

ServPro alleges they completed the job 2/19/2019 but did not advise homeowner, nor PDR nor State Farm, to the best of homewner's knowledge. Lockbox was not removed, and staff continued to visit site through early March.

No contract was provided to homeowner but a signature was requested on 2/4/2019 to "authorize commencement of work" - Copy not provided till May 2019. Has threatened mechanics lien. All dealings were directly with State Farm and they would take no directions from me; did not provide a contract, failed to complete the job and provide proper testing, and allege job completion 2/19/2019 (advised no-one) and failed to provide any evidence of completion. In November 2019 Field Adjuster inquired as to why the evidenced water damaged walls were not demolished; no reply.
